DECISION AND ORDER

Paul McNeil o/a Halifax Titanic Historical Tours applied to the Nova Scotia Utility and Review Board on March 11, 2025, for the issue of an Extra Provincial Operating License to operate in accordance with Appendix A attached hereto.

Notice of the application was published in the Royal Gazette on Wednesday, March 19, 2025, and notice provided to the industry. No objections were received by the March 26, 2025, deadline.

The application was considered by the Board without a hearing on March 28, 2025.

Having considered the *Motor Carrier Act*, including the factors set out in s. 13, the Board finds it is in the public interest to approve the application.

The Board approves the application, and orders that the license be issued as per Appendix A, attached hereto, effective immediately.
