NOTICE OF PUBLIC HEARING

IN THE MATTER OF AN APPLICATION by the **EAST HANTS WATER UTILITY** for approval of amendment to its Schedule of Rates and Charges for Water and Water Services and amendments to its Schedule of Rules and Regulations. This matter will be considered in a public hearing as follows:

Depending on the circumstances, all or part of this public hearing may be held virtually, by video conferencing.

Board Hearings are open to the public and you may participate as follows:

 You may request formal standing as an Intervenor, subject to Board approval. This will allow you to present evidence or cross-examine witnesses. Your request must be received by the Board by Monday, November 24, 2025, and a copy of your written evidence by Tuesday, December 23, 2025.

Additional information about the matter is as follows:

- For residential customers (5/8" meters), the current average quarterly water bill is \$144.67. It is proposed to change to \$180.91 (a 25% increase) in 2026/27; \$178.46 (a 1.4% decrease) in 2027/28; and \$184.92 (a 3.6% increase) in 2028/29.
- For all other metered services, the Utility is requesting amendments ranging from 27.5% to 32.4% in 2026/27; -0.9% to -1.0% in 2027/28; and 3.3% to 3.8% in 2028/29.
- The annual fire protection charge paid by the Municipality, currently \$711,098, is proposed to increase to \$815,422 (a 14.7% increase) for 2026/27, \$891,471 (a 9.3% increase) for 2027/28 and \$1,030,523 (a 15.6% increase) for 2028/29.

Upon reviewing the Application, the Board, in its Decision, may determine that the proposed amendments should be as requested, higher, or lower.
