NOTICE OF PUBLIC HEARING

IN THE MATTER OF AN APPLICATION by the **TOWN OF LUNENBURG** on behalf of its **WATER UTILITY**, for approval of amendment to its Schedule of Rates and Charges for Water and Water Services and amendments to its Schedule of Rules and Regulations. This matter will be considered in a public hearing as follows:

THE DATE AND LOCATION OF THE HEARING MAY CHANGE

If any Intervenor in this proceeding intends to file evidence, the timeline will be extended to accommodate this, and the hearing date will be rescheduled.

Depending on the circumstances, all or part of this public hearing may be held virtually, by video conferencing.

THE DATE, TIME AND LOCATION FOR THIS HEARING MAY BE CONFIRMED BY VISITING THE BOARD'S WEBSITE OR BY CONTACTING THE CLERK OF THE BOARD.

Board Hearings are open to the public and you may participate as follows:

- You may speak at the hearing. You must notify the Board by **Wednesday, May 20, 2026, of your request to speak.**
- You may make written comments by sending a letter to the Clerk of the Board at P.O. Box 1692, Unit "M", Halifax, NS B3J 3S3, or by using our secure file transfer service at <https://board.titanfile.com/NSRAB/>, or by fax at (902) 424-3919. by **Wednesday, May 20, 2026.**

- You may request formal standing as an Intervenor, subject to Board approval. This will allow you to present evidence or cross-examine witnesses. Your request must be received by the Board by **Friday, April 24, 2026**, and a copy of your written evidence by **Wednesday, May 20, 2026**.

Additional information about the matter is as follows:

- For unmetered customers, for the first dwelling unit, the current quarterly water bill is \$170.39, and it is proposed to increase to \$184.85 (an 8.5% increase) in 2026/27; \$202.98 (a 9.8% increase) in 2027/28; and \$218.25 (a 7.5% increase) in 2028/29. For each additional dwelling unit, the current quarterly water bill is \$53.66, and it is proposed to increase to \$60.68 in 2026/27 (a 13.1% increase); \$67.22 (a 10.8% increase) in 2027/28; and \$72.52 (a 7.9% increase) in 2028/29.
- For a 5/8-meter residential customer, the average current quarterly water bill is \$187.75, and it is proposed to increase to \$204.55 (an 8.9% increase) in 2026/27; \$223.72 (a 9.4% increase) in 2027/28; and \$239.48 (a 7.0% increase) in 2028/29.
- The utility is also requesting amendments for other metered services ranging from 9.2% to 12.5% in 2026/27; 10.2% to 10.7% in 2027/28; and 7.7% to 7.9% in 2028/29.
- The annual fire protection charge paid by the Town, currently \$328,900, is proposed to increase to \$330,989 (a 0.6% increase) in 2026/27; \$418,269 (a 26.4% increase) in 2027/28; and \$499,093 (a 19.3% increase) in 2028/29.

Upon reviewing the Application, the Board, in its Decision, may determine that the proposed amendments should be as requested, higher, or lower.
