Re: Fuel Adjustment Mechanism (FAM) Monthly Report – April 2026

Dear Ms. Henwood:

Please find enclosed Nova Scotia Power's FAM Monthly report for April 2026. The confidential versions of the report and the FAM Calculation Model have been uploaded to the Board's confidential website.

The analysis provided in this monthly report and the remainder of this letter uses NS Power's actual data against the 2026 GRA Compliance filing, referenced as the FAM Budget. The FAM Budget was originally developed using pricing data from November 2024.

For the AA and BA information on page M2, the actual data is compared against the amounts presented 2026 GRA Compliance filing, which includes actuals up to December 2024.

April 2026 Results

As shown in Figure 1, for the month of April 2026 there was increased energy from Solid Fuel, Natural Gas, and IPPs, which was partially offset by lower Energy Access Agreement imports, and lower energy from NSPI Wind, Hydro & Solar.

Month

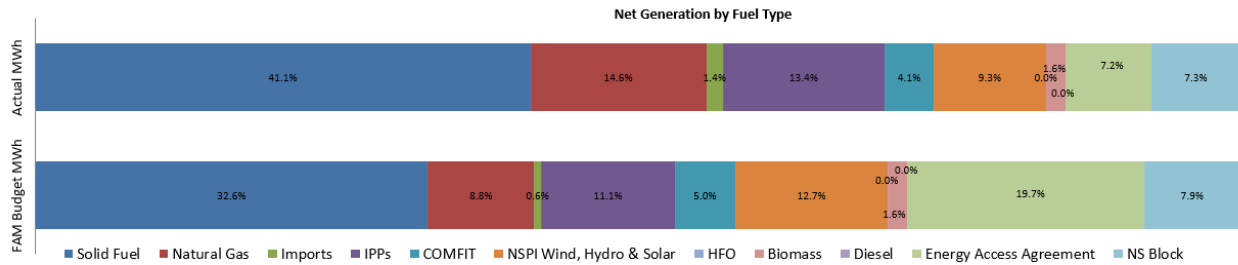

Year-to-Date

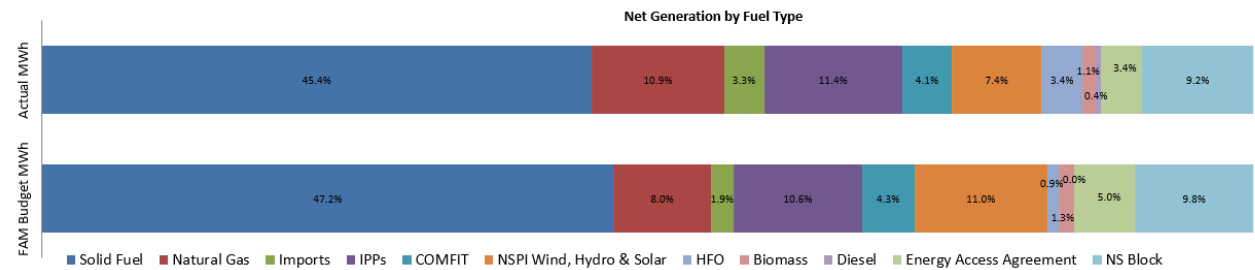

For the month of April 2026, there was an unfavourable variance of \$4.9 million in the recovery of fuel costs as compared to the FAM Budget (\$3.1 million actual over-recovery as compared to \$8.0 million over-recovery in the FAM Budget).

For the month of April 2026, load was approximately 51.4 GWh higher than the FAM Budget, resulting in an increase in fuel costs of \$3.6 million.

The April variance between the actual total fuel and purchased power cost and the FAM Budget total fuel and purchased power costs (excluding load) is unfavorable by \$3.2 million. The following table sets out the components of the variance between actual fuel and purchased power cost as compared to the FAM Budget.

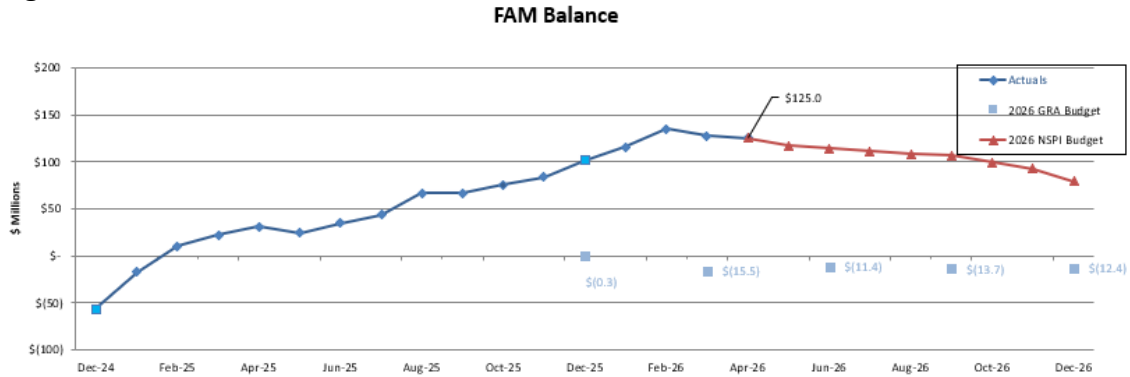

As shown in Figure 3 below, as of April 30, 2026, the FAM Balance is an under-recovery of \$125.0 million. Both the GRA and NS Power Internal Budget assumed an increase in fuel rates and collection of AA/BA beginning January 1, 2026.

As shown in Table 4 below, natural gas consumption was higher than budget. This was a result of increased natural gas dispatch compared to the FAM Budget.

In the Board Order received January 16, 2020, regarding M09810, in reference to the long-term deferral of Maritime Link depreciation expense, NS Power was directed to include detail in its FAM Monthly report of the WACC earned in the FAM on these funds. As of September 2021, energy from Newfoundland and Labrador Hydro (NS Block) has started to flow. Since January 2021, NS Power has deferred Maritime Link assessment costs in the amount of \$22.8 million, resulting in increased interest payable at WACC to FAM customers of approximately \$7.7 million.

Purchased Power Costs	11.7% below Budget for the month	April's \$22.7M was less than the FAM Budget of \$25.7M. Purchased Power was lower primarily due to lower energy available from Newfoundland and Labrador Hydro (Energy Access Agreement) and lower COMFIT generation than budget. Partially offset by an increase in non-wind IPP purchases due to legislation introduced after the FAM Budget was finalized that increased the rate paid for dispatchable biomass generation. In addition, 2 IPP Wind sites reached commercial operation earlier than expected resulting in more IPP Wind energy available to purchase.
Maritime Link	Equal to Budget for the month	April's \$13.3M was equal to the FAM Budget of \$13.3M.
Solid Fuel Costs	25% above Budget for the month	April's \$26.0M was more than the FAM Budget of \$20.8M. Solid Fuel expenditure increased due to increased generation as a result of total system requirements as well as to displace lower energy available from Newfoundland and Labrador Hydro.
Natural Gas	24.4% above Budget for the month	April's \$8.4M was more than the FAM Budget of \$5.8M. Natural Gas was higher primarily due to increased generation at Tufts Cove compared to budget. This was a result of lower commodity pricing driving the plant to remain in service due to economics.
Biomass Fuel Costs	26.3% above Budget for the month	April's \$2.4M was more than the FAM Budget of \$1.9M.
