2015 Ford 24-passenger vehicle 2007 Chev Supreme 18-passenger wheelchair accessible vehicle

Notice of the application was published in the Royal Gazette on Wednesday, October 1, 2025, and notice provided to the industry. There were no objections received by the stated deadline of October 8, 2025, since Blackwood Tours agreed with a potential objector to amend its application to include Cape Breton in all trip itineraries.

The application was considered by the Board in a hearing on October 9, 2025.

Having considered the *Motor Carrier Act*, including the factors set out in s. 13, the Board finds it is in the public interest to approve the application.

The Board approves the application, as amended, and orders that the licenses be amended as set out in Appendix A attached hereto, effective immediately.
